Subject: Proposed MCC By-Law Revision

The By-Laws have not been updated since November of 2011. The world has changed dramatically in the last 12 years. The Executive Board felt it was time to update our By-Laws. The are three types of changes in this revision:

- 1) Incorporation of the Alliance Defending Freedom (ADF) recommendations,
- 2) The creation of the Executive Board Supporters, and
- 3) Clarifying and Cross-references.

ADF Recommendations

In 2022, we joined the ADF Ministry Alliance Program (RELIGIOUS FREEDOM LEGAL HELP FOR CHURCHES & MINISTRIES). The ADF reviewed multiple camp documents including the MCC Constitution and By-Laws. The majority of the By-Law changes are the result of the ADF Religious Liberty Protections & Recommendations document. If we desire the robust religious liberty protections under the First Amendment, we are required to

- 1) clearly demonstrate our religious organization's character,
- 2) identify our specific religious beliefs, and
- 3) establish the sincerity of your beliefs.

Following is a summary of the key concepts that are being incorporated into our documents.

- The Three C's: These summarize ADF's recommended best practices for all churches and ministries to maximize your religious liberty protections.
 - 1. Communicate clearly communicate our sincerely held religious beliefs, with specificity.
 - 2. Core Documents consider all of the core documents and policies that flow from our sincerely held religious beliefs and ensure they are connected (e.g., Constitution/Bylaws, Statement of Faith, any supplemental doctrinal position statements, employee manual, wedding policy, facility use policy, job descriptions, camp application, camp rules, etc.)
 - 3. Consistency consistently communicate AND apply our sincerely held religious beliefs across the board. In a courtroom, consistency will become evidence of our sincerity.
- The "Big Three": the three protective statements that were recommend we consider in our Statement of Faith are clearly articulated beliefs on:
 - 1) Marriage,
 - 2) Sexuality, and
 - 3) Sanctity of Life.



The following By-Laws Articles were added to meet the ADF concepts as stated above:

Article I – Corporation (from By-Law Article XIII)

Article II - Address

Article III – History and Church Affiliation (from our website)

Article IV – Mission (Executive Board developed)

Article V – Vision (from our website, modified by the Executive Board)

Article VI – Statement of Faith (from our website)

- Added Marriage, Sexuality and Sanctity of Life paragraph
- Added the annual signing of the Statement of Faith

Article VII – Board of Representatives (ADF three C's)

Added bullets 2. and 3.

Article VIII – Executive Board (ADF three C's)

- Added bullets 3. a., c., d. and modified 3. e. & f.
- Added bullet 4. c.

Article X - Camp Director (ADF three C's)

Added bullets 3. through 7.

Creation of the Executive Board Supporters

There are currently a substantial number of individuals supporting MCC that do not attend a "supporting" church. Most were campers when younger and others have become engaged in adulthood. CONSTITUTION AND BY-LAWS OF THE MICHIANA CHRISTIAN SERVICE CAMP

CONSTITUTION

Article I - Purpose

The Michiana Christian Service Camp, in its endeavor to promote by Christian education and evangelism the restoration of the New Testament Church, its doctrine, ordinances and life; and to promote the unity of all Christians on the Bible and the Bible alone, shall conduct its work in harmony with the spirit and letter of the Word of God.

To this end, every member, trustee, treasurer and teacher involved thereby must be a member of the Church of Christ or Christian Church (un-denominational) and must believe, without reservation, in the full and final inspiration of the Bible to the extent that it is to him the infallible Word of God, and therefore, the all sufficient rule of faith and life; in the deity and supreme authority of Christ; obedience to the Gospel; the edification of the Church; and the restoration of its unity on the New Testament basis.

It is intended that this corporation shall be without exception autonomous, self-governing and without any kind of outside control. This corporation shall remain free from any affiliation with "connectional" religious groups or denominations, or any church body or group which makes any claim, expressed or implied, to the property, real or personal, or to the use of, or control over, the property of the members, or the churches from which they come.

All properties which are, or ever shall be owned or used by this corporation shall be used with approval of the Board of Directors of the corporation.

Article II - Membership

The Michiana Christian Service Camp shall have only those in its membership (Board of Directors) who support the purposes specified in Article I of this Constitution.

Article III - Amendments

Articles I, II, and III of this Constitution shall not be changed. The By-Laws can be amended or repealed by a two-thirds majority vote of the Board of Directors present at the regular annual meeting, or at any other meeting of the Board of Directors, providing a proper notice of such a meeting has been given.

BY-LAWS

Article I – Corporation

Michiana Christian Service Camp (hereafter identified as Michiana Christian Camp, MCC) is organized and operated exclusively for religious purposes and is qualified as a tax-exempt organization under Section 501 (c)(3) of the Internal Revenue Code (EIN 38-6111636).

Article II - Address

MCC is located on 7383 Steinbauer Road, Niles, MI, 49120

Article III – History and Church Affiliation

MCC is a religious non-profit corporation affiliated with the Churches of Christ and Christian Churches of southwestern Michigan and northwestern Indiana. Since Churches of Christ and Christian Churches are locally autonomous (no denominational headquarters or control), the camp is incorporated as an independent body with its own Board of Representatives. This Board consists of two to five representatives from each supporting congregation, with only two having voting privileges at meetings. The Camp President, Vice-President/Secretary, Treasurer, Executive Board members at-large and Trustees are all selected by this official body.

Long before MCC was officially organized, a program of summer camping for children was being regularly held by our brotherhood churches. Beginning in 1954, summer camps were held at various rented facilities as time and staff allowed. Because of several problems, such as high rental expenses, limited use of facilities, inadequate building and frequent interference by outside groups, it was soon decided to seek a "place of our own." In the spring of 1965, several interested area ministers met for the purpose of investigating this possibility. Having considered and rejected several possible sites, it was learned that a large farm northwest of Niles had just been offered for sale. On July 4, 1965, representatives from most of the area churches met at the "Moore Farm" and spent several hours walking over the grounds and discussing its potential. After considerable time in prayer, the group decided to go back to their respective churches and discuss the idea with their church boards. As a result, on September 9, representatives from the various churches again met and created MCC as an official and legally constituted Christian ministry.

Article IV – Mission

At Michiana Christian Camp, we're making Christ known through memorable experiences. Our mission is to meet people where they are and guide them to a deeper relationship with Christ. Our goal is to provide an avenue for discipleship that cultivates spiritual growth and empowers servant leaders who make a positive impact through serving their churches, communities, and the world in which they live.

Article V - Vision

Real Relationships. Lasting Impact.

(Our vision is to make Christ known by cultivating an environment where memorable experiences lead to real relationships and result in eternal impact.)

Article VI - Statement of Faith

We believe in one God, represented in the three persons of Father, Son, and Holy Spirit (*John* 14:6-21).

We believe in God the Father, eternal Creator of all things (Genesis 1:1; Hebrews 11:3).

We believe in Jesus Christ, the only Son of God, our Savior (John 3:16).

We believe that Jesus Christ was sinless, that He died on the cross to forgive man's sin, and that He was raised from the dead on the third day (Hebrews 4:14, 15; 1 Corinthians 15:3, 4).

We believe that after appearing to many witnesses, Jesus ascended into heaven, where He reigns at the right hand of the Father, and we believe that He is coming again to judge the living and the dead and to redeem the saved (1 Corinthians 15:5-8; Acts 1:1-9; Colossians 3:1; John 14:1-3; 1 Peter 4:5).

We believe in the Holy Spirit of God, who dwells in and guides every Christian (1 Corinthians 3:16; John 14:16, 17).

We believe that the Bible is the holy word of God, Scripture. We believe it is inspired by God without error; and our ultimate source for eternal truth (2 Timothy 3:16-17; Hebrews 4:12-13).

We believe that because of our willful disobedience, all men are sinners cut off from God, and that because of this each of us is without hope and deserving of death (eternal separation from God) (1 John 1:8, 10; Romans 3:23, 6:23).

We believe that salvation, the forgiveness of sins, and the promise of eternal life are available by grace alone: it is a gift of God and not a result of my own actions. A believer's salvation is secured only through Christ by the shedding of Jesus' blood and the sacrifice of His life (Ephesians 2:8, 9; Acts 4:12; 1 John 1:7).

We believe that the grace of God through Jesus Christ is received by faith when a believer becomes obedient to the will of God, confesses Jesus Christ as Savior, repents of sin, is immersed in water (baptized) according to the Bible, and continues to grow in obedience. (Ephesians 2:8; 1 John 1:9; Acts 2:38; 1 Peter 3:21; Philippians 2:12).

We believe in the Church of Jesus Christ, consisting of all believers worldwide, founded on the day of Pentecost. We believe that the church is to fulfill the great commission of Jesus Christ (Matthew 16:13-18; Acts 2:14-41; Matthew 28:18-20).

We believe that, as a Christian, we are God's workmanship, created in Christ Jesus to do good works, which God prepared in advance for us to do. These works are the fruit that result from remaining in the Vine (that is, Christ). Thus, by our fruit, we will be recognized as belonging to Christ – such fruit includes acknowledging Christ before men and meeting the physical and emotional needs of those around us (*Ephesians 2:10; John 15:4-5; Matthew 7:20; Matthew 10:32; Matthew 25:35-36; Acts 2:42*).

We believe God created man and woman in His image and uniquely and exclusively male and female, and that each life is sacred and worthy of protection upon conception (*Genesis 1:27; Psalm 139:13*).

We believe God designed marriage to be a sacred, lifelong union between one man and one woman and God purposes that sexual intimacy is designed only to occur within that biblical union (Mark 10:5-9; Genesis 2: 18-25; 1 Corinthians 6:12-19; Romans 1:26-27).

On an annual basis, each Board of Representative member, Executive Board member, Executive Board Supporter (Article VIII, 2.) and full-time Staff member will sign the MCC Statement of Faith. Additionally, all summer staff, deans, faculty and ministry leaders will sign the Statement of Faith prior to commencing their onsite activities. Refusal to sign the Statement of Faith will result in the individual not being able to function in a leadership (or leadership support) role at MCC.

Article VII - Board of Representatives (formerly referred to as the Board of Directors)

- 1. The Board of Representatives shall be responsible for the oversight and direction of all functions and activities of the corporation.
- 2. The Board of Representatives shall ensure the ministry sets effective goals to attain its religious purpose of reaching others for Christ.
- 3. The Board of Representatives members will regularly pray for the ministry.
- 4. The Board of Representatives shall consist of two (2) people from each Church of Christ or Christian Church (un-denominational) contributing in the camp work by furnishing one (1) or more students or making a financial contribution to the camp in the preceding calendar year.
 - a) Representatives must be active members in good standing within the church they are representing.
 - b) Participating churches are responsible for selecting, appointing and registering their representatives. A church may register as many as five (5) representatives.
 - c) Only currently registered representatives will be able to vote on any matter coming before the Board of Representatives.

- 5. An Executive Board shall be elected by the Board of Representatives at the regular Annual Meeting for a three (3) year term. These individuals are not required to be members of the Board of Representatives but must satisfy the requirement of Article, VII 4. a). Serving on the Executive Board will be:
 - a) President: Chairman of the Executive Board and the Board of Representatives.
 - b) Vice President/Secretary: Functions in the place of the President when he is not available and ensures meeting events are recorded and distributed.
 - c) Treasurer/Financial Secretary: Maintains oversight of collections, records and management of all funds of the Corporation.
 - d) Members at large [a minimum of five (5) people]: These individuals will serve in various capacities, as appointed.
 - e) Camp Director
- 6. A quorum of the Board of Representatives shall consist of those present at a duly called meeting.
- 7. Each church (Article VII, 4.) shall have no more than two (2) votes.

8. Board of Representatives Meetings

- a. An Annual Meeting will be held in November at a time and place determined by the Executive Board to permit the majority of the Representatives to attend. Reports from all committees and/or ministry groups will be reviewed at this meeting.
- b. Other meetings may be called as deemed necessary by the Executive Board. A written notice (including e-mail communication or other technological advanced written communication agreed upon by the recipient) announcing each meeting will be sent to each member church (and registered Board of Representatives member) and shall be postmarked (or electronically dated) at least two weeks prior to the meeting date.
- 9. In the event of the simultaneous vacancy of one-half (½) of the officers on the Executive Board, the remaining Executive Board members shall call a special meeting of the Board of Representatives for the purpose of selecting new officers to fill these vacancies.
- 10. In the event of the simultaneous vacancy of the Executive Board and there are less than three (3) members remaining (an insufficient number to meet the state's trustee requirement), a special meeting of the Board of Representatives shall be held for the purpose of filling these vacancies.
- 11. Requirements, functions and areas of responsibility for the Board of Representatives, Executive Board Members, Employees, Volunteers and others shall be kept on file in the corporation's "Standard Operating Procedures Manual." Copies of these descriptions shall be available upon request.

12. Any officer or representative may be suspended or removed from the Board of Representatives, Executive Board or any other group or committee for conduct unbecoming a Christian, or for lack of commitment and service to the position they have been appointed. Refer to "Standard Operating Procedures Manual" of the Corporation for details.

Article VIII - Executive Board

- 1. The Executive Board operates under the express authority of the Board of Representatives.
- 2. The Executive Board may consult with individuals (Executive Board Supporters) not attending a MCC supporting church when needed to support the successful completion of Article VIII, 3.
- 3. Responsibilities of the Executive Board shall include:
 - a. Regularly pray for the ministry.
 - b. Serve in an advisory and supervisory capacity in overseeing the work of the Camp Director.
 - c. Work with the Camp Director in setting both short-term and long-range spiritual goals for the camp.
 - d. Assist the Camp Director in implementing the spiritual programs and goals of the camp.
 - e. Work with the Camp Director in setting both short-term and long-range physical goals (maintenance, grounds upkeep and capital expansion) for the camp.
 - f. Assist the Camp Director in implementing the physical goals of the camp.
 - g. Provide support (Article VIII, 4. c) for the Camp Director in matters of discipline and/or other personnel or camper concerns.
 - h. Develop a Budget to be presented at the Annual Meeting of the Board of Representatives.
 - i. Review all proposed business and draft an agenda for the Annual Meeting.
 - Draft a written agreement with the Camp Director covering such areas as duties, salary and vacations.
 - k. The Executive Board shall have the authority to remove, suspend and/or terminate a Camp Director by two-thirds (¾) vote of the entire Executive Board.
 - I. Serve as a "search committee" to seek out, interview and recommend a candidate for the position of Camp Director.
 - m. Establish committees as needed (e.g., Program, Grounds Upkeep and Maintenance, etc.).
 - n. Execute any legal documents including those pertaining to the acquisition of properties, purchases or lease agreements at the direction of the Board of Representatives.

4. Disciplinary Action:

- a. In the event of a deed of misconduct (non-compliance with Scriptural truth) by a camp dean, faculty member, camper, professional staff person, or other individual representing the camp, on site or off, the principles of Matthew 18:15-17 and Galatians 6:1 will be used for restoration and/or discipline. Final action may result in suspension or removal from one's position. The Camp Director has the authority to administer discipline following the Matthew 18 principle in routine matters. In extreme cases (e.g., drugs, alcohol, and imminent danger to campers or others), the Camp Director may take any action he deems appropriate. The Executive Board, or designated committee, will constitute the 3rd step in the Matthew 18 principle of taking the matter before the church.
- b. The Executive Board reserves the right to bar from participation, any individual who is currently involved in behavior (e.g., theft, adultery, homosexuality) which is not becoming of a New Testament Christian.
- c. The Executive Board is the final human interpreter of the scripture for MCC. The Executive Board has the final responsibility of ensuring the spiritual integrity of the MCC is maintained.
- 5. Meetings of the Executive Board shall be called at the discretion of the President, Vice-President/Secretary, Treasurer or the Director.
 - a) A quorum shall consist of a majority of the members of the Executive Board.

Article IX - Finances

- 1. All major (>\$2,000) non-budgeted or gift specified disbursements must have prior approval of the Executive Board.
- 2. All minor (<\$2,000) non-budgeted disbursements must have prior approval of the MCC President and an additional Executive Board member.
- 3. The Fiscal year of the corporation shall begin on the 1st day of January and will end of the 31st day of December each year.
- 4. There will be an annual review and/or audit of the Treasurer's books.

Article X - Camp Director

- 1. The Camp Director, upon recommendation of the Executive Board shall be confirmed by a two-thirds (¾) majority vote of the Board of Representatives at any properly called meeting.
- 2. The Camp Director shall be a member of the Executive Board and an ex-officio member of all other Boards and Committees.
- 3. The Camp Director will hold a weekly spiritual development and prayer meetings with the full-time staff.

- 4. The Camp Director will ensure a weekly list of prayer needs is distributed to the Executive Board.
- 5. Ensure the spiritual needs of the summer staff are being ministered to.
- 6. In cooperation with the Executive Board, oversees the development and implementation of the MCC's spiritual vision (e.g., program and event development).
- 7. In cooperation with the Executive Board, oversees the development and implementation of the MCC's physical goals (facility usage, maintenance, grounds upkeep and capital expansion).

Article XI - Trustees Committee (The responsibility of the Trustees Committee has been incorporated in Article VIII, 3. n.)

Article XII - Compensation

No part of the earnings of the corporation shall incur to the benefit of, or be distributed to
its members, officers, or other private persons, except that the corporation shall be
authorized and empowered to pay reasonable compensation for services rendered and to
make payments and distributions in furtherance of the purposes set forth in the
Corporation's Articles of Incorporation.

Article XIII - Dissolution of the Corporation

1. In the event of dissolution of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which is qualified as a tax-exempt organization under Section 501 (c)(3) of the Internal Revenue Code of 1986 as amended. Such distributions shall only be made to a Christian Church/Church of Christ or to an approved New Testament Restoration institution such as one of our brotherhood's Bible Colleges. No person or persons shall be entitled to share in the distribution of any of the corporate assets upon the dissolution of the Corporation. Assets of the Corporation will be distributed by the Board of Representatives.

Staffing

We have had more transition this year in our staffing. We made a very tough decision to move on from our previous Communications Coordinator and created an entirely new position titled Program and Communications Coordinator. We went through an extensive hiring process over the summer and ultimately made the decision to hire Eric Christian to fill the position. Eric has 30+ years of MCC experience. He brings many different hats to the table. Over the years he has served as a dean and faculty at our camp as well as others, has sat on the board here at MCC as well as the statewide



youth convention. He has served as a youth pastor as well as a local associate minister. He is passionate about seeing kids grow in Christ and is a true visionary. We are excited to see how God is going to use Him to further His plans here at the camp. I am excited to share with you that our Business Services Supervisor, Kelly Hullah, has been identified as a leader in her position, and has been asked to serve on the Christian Camp Leaders Board as their Secretary/Registrar. She probably won't tell you this, but it is a testament to her service and dedication to who she is in Christ and how she faithfully serves to the best of her abilities.

Our Facilities Supervisor, Andrew Hullah, continues to faithfully serve and look for new ways to expand his knowledge to serve the camp. Andrew saw potential for us to save money and decided to take a class to become HVAC certified. I'm happy to report that he passed with flying colors! We are now able to buy parts at a discounted rate, and Andrew will be able to tackle some of the HVAC issues that arise at the camp.
